And, he is obviously travels all over and speaks and, he's spoken on many stages, many events, and he's been featured in several documentaries. And anyway, so, Dr. Brian artists. Good to see you.

Great to be here with you, Chris. You know, I think the last time I, actually heard words from you directed in any way to Dr. Artists, I believe it was a tour throughout Florida. That was a multi-city campaign and you were on the stage. I was on the ticket, but I was banned by our own people who say no to censorship. decided it was best to censor Dr. Artists from these seven.

to save a generation tours through Florida. But I heard from multiple people, Christian and Northrop and others who were on the shared stages with you, Peter McCullough and others, that you actually spoke up on stages and condemned those who actually had censored me from being able to participate in those events. And that was actually one week from my *Watch the Water* documentary that obviously shook a lot of people's souls and their beliefs and openness.

And, but yeah, when, when, when you came out with some of these revelations, which we'll get into, especially about venom, yeah, I think it's put a lot of people on their heels and, it was very unfortunate that there were some doctors who didn't want

I want you to know people had revealed to me through text. persevered and I think you've done so much incredible research on this topic, which we'll get into. And I'm just going to hold up your book because it's a great book. I've read it. I'm moving beyond the COVID-19 lies. highly recommend the book folks. you read it, just, just brace yourself cause you're going to learn some things and see some research and what we're about to get into it. promise that you've never heard that you had no idea existed and

Dr. Artis did a great job with all the citations and even, I he went even screenshotting studies and pictures in the book of the studies, all kinds of stuff. So, all right. So where do we start? Do we want to go all the way back to COVID?

Uh, sure. We can do that. All right. So you have an incredible story of triumph over a condition that should not just go into remission. It might repeat itself and you've been able to persevere and beat cancer as you were diagnosed with before that we covered on our own show years ago. And yeah. So who am I to your audiences? Maybe they don't even know who I am, but for those of you that don't know, I'm actually a retired chiropractor, acupuncturist and nutritionist. Uh, I retired in 2018 from

clinical practice, sold my second practice. I had sold two practices, one in Tennessee, and then the last one in 2018 here in Dallas, Texas. And then within a year and two months of retiring or selling my practice officially is when, my father-in-law walked into a hospital in February, 2020 and never walked out and was killed due to a very ill-advised toxic, deadly combination of drugs for what they had diagnosed incorrectly as the flu.

When in fact, he had never tested positive for the flu, even though they said he did. And I went through all their path labs with the doctors on day five. He never actually tested positive for anything, but they lied so they could bill Medicare to get paid for a protocol and admit him, but they have to have a code and a diagnosis. So they decided to diagnose them with the flu and the cocktail of drugs. put him on shut down his kidneys within 24 hours, flooded his lungs with water called pulmonary edema. And they misdiagnosed that as pneumonia.

And then on his death certificate, 11 days from entering the hospital, they actually wrote cause of death was pneumonia. When in fact, he never had pneumonia and never tested positive for pneumonia the whole time he was in there, bacterial or viral. So to just write that down as a blanket sweep was their, their ability to bill Medicare and his, uh, additional health insurance policies for as much money as they could get out of them for his last 11 days on earth.

And for me, that was a very hard time for me on day seven. I was kicked out of the hospital when I challenged the protocols, face to face me with the medical professionals and nursing staff. they kicked me out of the hospital with security, escorted me out, told me and my family that they would never talk to me again, ever work with me again. And,

Yeah. On day six, actually we worked together and changed the protocols. You can read the whole story in the book. It was really great. We all worked together. Medical doctors, the team, administrators, nurses, they all would work with me. And for four hours, we changed this entire protocol and he came back to life, literally came off the breathing apparatus, clear lungs, peed out 20 pounds of water. they didn't have him on anything to drain his water out of his lungs. So

all I did was tell him to put them on Lasix, which they refused to do for five days or told me they had done and never did.

But one day for 20 milligrams, can read the story in the book. But when I exposed that you could just change your drug treatments and he'll come back to life. Everything we had been hearing for five days were results of the drugs they were giving him. So when I just said, change the drugs, they did it. And his whole life came back and he became conscious. He was on a breathing machine up until this point and unconscious. He became conscious in four hours of changing the protocols. When we went home, there was a secret meeting.

Literally the words from the nursing staff was a clandestine meeting was held after y'all left and the hospital administrators, the medical doctors and the nursing staff all met together and we were told to call you and tell my wife, his daughter, that they were never going to talk to me again. They were going to go back on the original protocol. And if I ever speak or come to that hospital, I'll be escorted out by security. And they did that the very next day after a big showdown in the hallway, across from his room.

And anyway, they then put him on palliative care after escorting me out of the building, convinced my family, my wife that, it's best to put him on palliative care, which is drugging someone to death in front of you for profit while they die. This is no different than taking your dog or cat to a veterinarian and saying it's time to put them down. This is what they do. They use micro dosing of morphine, medazolam, presodex, lorazepam, fentanyl.

to drug your loved one to death. Those drugs cause respiratory failure. That's what they're designed to do. And if you can't breathe, you die. So this is palliative care and hospice, murder for profit. The same thing Kvorkian did and allowed people to do on their own. He went to prison for, the whole reason why he went to prison by the way, is because the hospitals didn't make any money off of the drugs and the protocols to bill insurance for, murder for profit. So three months later after he dies in the hospital, in my anger and upset,

Uh, I started hearing that there was this mysterious infection in the news spreading like wildfire in the news that I don't watch. I've never watched the news ever about this infection in New York city. And I'd heard some friends of mine say, what do you think about all these tractor trailer loads of bodies of people dying in hospitals in New York city in may of 2020, three months after my father-in-law's death. And I said, I don't even know what you're talking about.

And so I went home and I looked up a few videos on YouTube. Actually, I wanted to just watch news clips of this New York city epidemic, whatever it was. They called it the epicenter of COVID. And as I'm listening to the doctor's talk, they all say the same thing. We've never seen a respiratory virus ever do this from the moment we start treating them within 24 hours, the virus leaves the lungs and goes to the kidneys and shuts down their kidneys. And in unison, they all said the same thing.

We not only have a shortage of breathing machines here in New York city, we have a shortage of dialysis machines to handle the acute kidney failure. Well, ding ding everybody. I had just watched this happen day by day by a drug induced protocol from a hospital verbatim within 24 hours. dad, my father-in-law was diagnosed with acute kidney failure that he didn't have before that. And then diagnosed with pneumonia that afternoon, which is the water was filling up in his lungs, just like these people in COVID.

I thought they use the same protocol on these people in New York. That's why I ever, the only reason why anybody even knows who I am is because at home retired, I went online and I wanted to know what's the hospital protocol they're using for COVID patients in New York city. And when I went to the CDC's website, because I'm very familiar with that website for years of practice doing research on the CDC's website, I thought Chris, of all places,

The hospital protocol or treatment protocols for an infectious disease would be at the centers for infectious diseases called CDC, the centers for disease control. I figured they're trying to control the disease. Maybe they have the thing. No, when I go to the CDC's website in May of 2020, there is zero tabs, zero searchability for COVID-19. When I did type in COVID-19, this little memo window pops up and it says,

We are redirecting you to the NIH's website, nih.gov, because that's where the hospital protocol is. So I just click the link, takes me to NIH, where I'd never been. And all there is is this one page in May of 2020, a three paragraph memo titled, Mandatory Hospital Protocol for COVID-19 Infected Americans. And it was by Dr. Anthony Fauci. And I read that there is one drug allowed and being mandated in New York City at this time.

But for all hospitals in America, they can only use one drug to treat this COVID viral infection. And it is called remdesivir. And I had never heard of this drug. And he said it was proven safe and effective against two other infections, one called Ebola and the other one called COVID in January to March of earlier that year. And the Ebola trial in Africa was in 2019. He said, I quote, in both trials remdesivir was found safe and effective against Ebola and against COVID.

So I just click the links cause I am retired and I just want to know what the hell is this drug and my God, imagine my shock.

He died as a result of medical treatment, but that, that primed you, didn't it? If that had not happened, you would not have had the, you would not have been in the state of mind to

question and research what was happening when COVID started, right? You wouldn't have made that connection.

I never would have ever even went to go look. actually thought Chris, the only reason why I even went to go look for the hospital protocol. I thought they must be giving them the same drug they gave my father-in-law. Cause this is, that was a respiratory virus called the flu that he didn't have. And then they used a viral protocol supposedly, and it killed him. And I was like, my God, it caused acute kidney failure, filled their lungs with water. They died from this thing they called COVID pneumonia.

You would, you wouldn't even know who I am. retired. I was done. I'd set up my life financially. I was fine at 40 years old. I was fine. Like I'm fine. If I want to go do something, I'll do it, but I'm going to pick it on my terms. had no idea that the universe and the elites of the world were going to force me. felt like force me to go challenge their narrative.

And I really did truly, you were correct. It was very, it would have never happened. It wasn't for my father-in-law dying and my wife to this day, no matter what state Capitol building I was testifying in when I was asked to testify in the King's court and parliament during COVID, when I was being asked all over the place to testify to these deadly protocols and hospitals that were the cause of the majority of all deaths related to COVID, not COVID. mean, I could show you all the state and all the stats, all the data, me and Peter McCullough were everywhere and other medical doctors testifying and Capitol buildings everywhere.

I need to go see how many people around the world I will never meet. I can save their life and keep them from going to the hospital.

And I mean, we had the hardest time visiting him or, you know, visitation was extremely limited. At one point he was in, he was in a rehab facility that didn't allow visitors at all. is they were constantly quarantining him. Cause anytime someone on the floor, was on tested positive for COVID, they would quarantine the whole floor. So there's like weeks at a time that

he kept being quarantined, quarantined, quarantined, they kept testing it for COVID and he never tested positive as much time as he spent in these facilities. Like it was pretty crazy. Never tested positive for COVID. But anyway, let's jump back because so you, you, you click through the links, you're trying to figure out, okay, what is this drug they're giving?

to COVID patients in the hospital and what was it?

Yeah. The first study is of a 2019 study of remdesivir that Anthony Fauci's memo I'm reading says in this trial hyperlink to the research study in this trial, it was found safe and effective against the Ebola virus. And I just clicked the study to go read it. Cause I didn't believe it. I was like, well, let's just go read it. So I clicked it and read it and could not believe what I was reading. This was a trial in four different parts of Africa and they took.

four different drugs in four different parts of Africa, and we're doing a human clinical trial to see if any of these four drugs work the best for Ebola. And in the trial, at six months, the safety board for the trial, who is unbiased, independent, they notify the funder of the study in August of 2019. They say to them,

We are suspending the drug remdesivir because now that we're reviewing the data for the first six months, there's only one drug of the four in this trial that has a higher death rate than Ebola does. There was only one drug that killed more than 50 % of the people taking those drugs for the trial, and it was the remdesivir drug trial participants. So they said, we have to cancel this drug. The other three are safer, but the other drug had a

death rate of 49%. So they canceled that one and remdesivir, but remdesivir was the big dog. We gotta get rid of that one. It's killing way more people than the drug, the infection itself. Now I'm reading this and I'm like, oh my God, who funded this study? Because this guy, Dr. Anthony Fauci on the memo I'm looking at on the screen says it was proven safe and effective. So I'm like, was he just giving bad advice? Who funded this thing? Imagine my shock, Chris, to go down to the end of the research study, which I've read my whole adult life. I love research studies and diving into them and love science and data.

I go to the funding section of the study. Imagine my shock that it's Dr. Anthony Fauci's department at the NIH who funded the Ebola trial for remdesivir, which means on his desk, in his email in August of 2019, he got a memo saying remdesivir is the most deadly toxic drug in this trial and it is banned. It is not safe. It is not effective against Ebola. It is banned. And then in May of 2020,

If the powers that be are trying to protect him from ever testifying, ever being deposed.

Ever that it can't happen. No, we're going to just do a blanket preemptive pardon. No one can ever talk to him about anything that happened during COVID. my God. then. You know, I found amazing Chris. And I do dive into this in my book about the hospital protocols, tell the story of my father-in-law, but the most shocking thing in state Capitol buildings, Peter McCullin, I, Thomas Renz and I, the attorney, we were in like 20 different state Capitol buildings testifying to those legislators and senators who were brave enough during lockdowns.

to come into the state capitol buildings to visit with us. And we would, I mean, you can watch all the clips online. We would just show them all this data one after another after another. They

were amazing. Pennsylvania was amazing. Montana was amazing. But as we present this stuff, every single senator legislator would look at us, even in Kansas, they'd go like this. Thank you for showing all of us this stuff. Dr. Artis, why do you think this is happening? Why do you think?

They are allowing remdesivir to be the only drug allowed. And why are they punishing doctors if they give anything else like ivermectin, hydroxychloroquine or other products? Why do think they're being punished? And I'd go like this, hold on, I have to show you something. And this is what bothered them the most. I couldn't believe it. I knew why it bothered them, but it should bother you, Chris work and everyone watching. Please someone explained to me. You have the entire country, the United States.

All thousands of hospitals in America are being told and every doctor and nurse that works in there, you're being told for the four years of COVID, there's only one drug you are allowed to use, period, period, period as an antiviral for this viral infection they called COVID. There's only one. And if you use any other one, you lose your rights to be paid to work at this hospital. You lose your rights to have access and privileges at that hospital. You're just fired.

Or you might lose your license altogether if you use any other drug but Remdesivir. Why to this day for those four years and even now are all hospitals being given a 20 % total bill bribe bonus if you will just give this one and only allowed drug to be used called remdesivir, if you'll just give it to every patient.

who is 60 years old and older on Medicare of Medicare aged, we will give you a 20 % add-on bonus to the whole hospital state. When I would show the CMS.gov's statement that we will give you a 20 % add-on bonus to the whole bill if you just give remdesivir to the COVID-19 positive Americans older than 60, every legislator and senator sitting on the stand would look at me, look at Dr. McCullough and they'd go, why is Medicare doing this?

And I'd go like this, there's only one you're allowed to use. Why would they have to offer a bribe? A bonus if you'll just use it. Why would they incentivize hospitals to use the one and only drug they're allowed to use anyway? It doesn't make any sense. So then I would turn it around on all of them, Chris, and I'd go like this. Why would the government mandate that only one drug could be used to treat it?

That's never even been proven to treat it. Why would they do that? Right? Even just on the surface, that question right there makes no sense. Like there's no study proving it works and yet it's the only drug you're allowed to use. Now, if you were in charge, if I was in charge, if I'd say 99 % of my listeners were in charge of the government during a pandemic, I think what they would have said was, okay.

You know, this is serious. We don't know what it is. It's a new virus, whatever, but hospitals, doctors, nurses, practitioners, do your best. Use all of the resources you have available to you. Use your training and your experience and the medicines you have and the medicines you can research and learn about. Use your everything in your toolbox and report back to us what's working. Right? That's the way it should have gone.
